

He Should use reasonable diligence to ascertain their quality. The B3rrr6 principle applies when the purchaser seeks to avail himself of deceit in the defense of a suit for the price of the goods or in reduction of damages. To the same effect is the case of Mooney v. Miller, 102 Mass. 217. But it...
